Discretionary FTA Grant Award

- RTA Awarded \$2.6M in Discretionary FTA Funds for E-Buses
- Press Conference with Congressman Carbajal to announce *Bipartisan Infrastructure Law* funded projects in SLO County



Morro Bay Transit Consolidation into the RTA

- Morro Bay Transit currently operates one weekday deviated fixedroute, and seasonal trolley service
- If approved by City Council, develop agreement similar to the one with the City of Paso Robles
- <u>Possible Timeline</u>:
 - Nov. 6: The agreement draft would come to the RTA Board
 - January 2025: possible ratification by RTA Board
 - March 2025: interviews with MV Transportation drivers
 - Late-May 2025: possible start date



Possible Atascadero DAR Consolidation

- Atascadero Dial-a-Ride operates up to two vans on weekdays.
- Service currently contracted to MV Transportation
- Provide a proposal to City staff within two weeks
- Update at the November RTA Board meeting



Bus Operator Recruitment Update

- Six new Bus Operators in revenue service & one more nearing completion of training since previous update
- Three candidates in background checks
- Still four open Bus Operator bids



PV Solar System Update

- RTA secured \$956,722 in funding to implement a photovoltaic solar system; additional funds brings total to \$1.3M
- Need a 282.9kWdc solar array = 480.8MWh in annual production
- Funding allows onsite solar generation, and possible battery backup storage system
- Will seek Board authorization at the November meeting for Design/Bid RFQ



Initial BEB Operating Results

- First two BEBs delivered in March
- Entered revenue service July 15th on Route 12
- Use of energy per mile is lower than expected
- Plan to test on Route 10 next to evaluate battery usage and capacity



Marketing & Communications

- Over 50 personal trip plans, mostly for Cuesta students
- New school districts partnership
- Beginning work on Cal-ITP
- New "How to Ride" video on website
- Bus stop improvements: Ramona and Templeton shelters
- Company Newsletter at end of report

SB 125 Projects Planning

Aligning resources to implement projects in the SB125 Allocation Package:

- Funded with new discretionary *TIRCP* and *ZETCP* funds
- Focused on BEB and recharging projects
- Seeking Board authorization in upcoming meetings



FY23-24 Operating Results

Unaudited operating & financial results FY23-24:

- RTA fixed-route ridership increased 9.5% over last year but still 35.9% below pre-pandemic totals
- Paso Robles local routes is up 15% but South County routes are still 17.7% below FY18-19
 - Ridership of local routes improving faster than longer/intercity routes
- Runabout ridership increased 15.3%



FY23-24 Financial Results

- Slightly below budget at 95.6 % of Annual Budget
- Farebox Recovery Ratio results:
 - RTA Intercity Fixed-Route 9.4%
 - Runabout 2.9%
 - Paso Robles 15.1%
 - South County 4.7
- Subsidy per passenger results:
 - RTA Intercity Fixed-Route \$14.95
 - Runabout \$134.65
 - Paso Robles \$6.87
 - South County \$11.91

- Executed amendment to conduct additional analysis; \$8,295 is within budget.





Possible Fare-Sharing Agreement with MST

- Monterey-Salinas Transit operates two daily Route 84 roundtrips between King City and Paso Robles
- RTA operates two Route 9 roundtrips to/from San Miguel, plus one early-morning Express on weekdays
- However, riders using both systems cannot currently use a single discounted pass
- Staff negotiated a pass-through payment to MST which allows riders to us our Regional Pass



Possible Fare-Sharing Agreement with MST

- Estimate 3,180 annual boardings on MST buses
- Pass-through of \$4,770 in first year to MST
- RTA would review quarterly ridership results, and be prepared to renegotiate for future years
- Good example of regionalism in helping to meet the needs of Central Coast residents



Staff Recommendation

Authorize the Executive Director to sign the MOU with MST for those using Regional Passes to board MST Route 84.
